### Farm labour questions (page 5)

Instructions on completing these questions are provided on the form itself. However it is our experience in previous years that these questions can prove problematic. Therefore, if you are unsure on how to complete these questions, we would encourage you to contact us and one of the team will be happy to help.

For the purposes of this form, **regular workers** are defined as anybody normally engaged in agricultural or horticultural work on the holding throughout the year (provided they are at least 16 years of age).

NB they need not be present/working on the actual day – as long as they are still employed to work on the holding.

Full-time is defined as anyone who, on average, works 39 hours or more on the holding per week.

However the following should **not** be included on the form:

- gardeners, groundsman, gamekeepers and grooms (and similar);
- farm shop workers, sales assistants in garden centres and others only retailing farm produce;
- prison inmates or students working on college farms.
